

If required, they may assign the additional charges to other officers within their jurisdiction under intimation to this office and any difficulty faced be brought to the notice of this office immediately.

All the Inspectors in the existing formations are directed to hand over the files/registers/records to the respective Superintendent/ Inspectors in the GST formations in accordance of jurisdiction as per Trade Notice No. 01/2017 dated 21.06.2017 issued by the office the Chief Commissioner, Central GST & Central Excise (erstwhile Central Excise and Service Tax), Ranchi Zone, Patna and send the compliance to the jurisdictional AC/DC.

All the representation received till date in the grade of Inspectors regarding transfer & posting within Central GST & Central Excise Commissionerate, Patna- II stand disposed off.
