


**Office Order**  
**Dated:-07-12-2016**

In exercise of the powers conferred upon me under sub-rule 3 of Rule 13 of the Delegation of Financial Power Rules, 1978, I, Sheo Narayan Singh, Principal Commissioner, Central Excise & Service Tax, Commissionerate Patna, hereby, delegate the powers of the Head of the Department conferred upon me under sub-rule 1 & 2 of Rule 13 (ibid) to Shri Pratul Tiwari, Joint Commissioner, Central Excise & Service Tax, Commissionerate Patna with immediate effect and till further orders as under:

2. The delegation contains all the powers of Head of Department under schedule V & VI of the Delegation of Financial Power Rules, 1978 and as indicated below:
  - I. The power of incurring contingent expenditure under schedule V of the Delegation of Financial Power Rules, 1978.
  - II. Power to incur miscellaneous expenditure under schedule VI of the Delegation of Financial Power Rules, 1978.
  - III. Power as contained in Fifth Schedule to GPF (CS Rules).
  - IV. The powers of Head of Department under Central Civil Services Leave Rules, 1972 in so far as these relate to Group "B" and "C" officers/staff of the Commissionerate/Divisions without any limit.
3. The above delegation of power is subject the provisions of Rule 13(4) of the Delegation of Financial Power Rules, 1978 and column 3 of the Annexure to Schedule-V of the Delegation of Financial Power Rules, 1978.
4. Further, in terms of rule 14 of delegation of the Financial Power Rules, 1978, I, Principal Commissioner, Central Excise & Service Tax, Patna as Head of the Department, hereby declare the said Joint Commissioner, Central Excise & Service Tax, Patna as Head of the office in respect of Group-A, B & C officers posted at the Central Excise & Service Tax, Patna. As Head of office, he will attend to all related matters including the following:-
  - I. TA/TTA/HTC/LTC advance/final claims.
  - II. All short terms interest free/interest bearing advances.
  - III. Medical claims/medical advance bills/permission for OPD treatment in referral Hospital etc.
  - IV. GPF advance/Part final withdrawal.
5. He will be responsible for correctness, regularity and propriety of the expenditure incurred under the Powers delegated above and will maintain economy in expenditure.
6. This order supersedes all the previous orders on the subject.
