OFFICE ORDER

Dated: 09.10.2017

Based on the decisions taken in the 9th and 21st Meeting of the GST Council, principles regarding division of taxpayers between Centre and the States have been propounded. For division of taxpayers according to such principles GST Council has issued Circular No. 1/2017, dated 20.09.2017. As per Para 3 of the said Circular, a State Level Committee comprising Chief Commissioner/Commissioner of State Commercial Tax and jurisdictional Central Tax Chief Commissioner/Commissioner in the state of Bihar has been authorized for division of taxpayers. The Central Government representative Commissioner, Central GST & CX, Patna-I and Commissioner, Central GST & CX, Patna-II will be the members of the State Level Committee as communicated vide letter C. No. V (30)20-CCO/Pat/Tech/GST/2017/10969-71 dated 26.09.2017 of the Dy. Commissioner (CCO), CGST & CX, Ranchi Zone, Patna.

2. With a view to timely complete the process of division of taxpayers between the Central Government and State Government according to the parameters prescribed by the GST Council, a decision has been taken to constitute a team of officers of Central GST to help the State Level Committee. These officers shall submit the list, data, etc. relating to the taxpayers as per the decisions and parameters set forth in the 21st Meeting of the GST Council to the State Level Committee. For this purpose these officers shall hold minimum one meeting in each week; and, in case of any doubt regarding the division of taxpayers as per the prescribed parameters or otherwise, shall seek necessary guidelines from the Committee.
