With the roll-out of GST (Goods & Service Tax), the taxes of Central Excise and Service Tax would be subsumed in the GST. So a current Central Excise/ Service Tax taxpayer would need to migrate to GST portal. To facilitate migration to GST portal, office of the Commissioner, Central Excise & Service Tax, Patna has organized “**GST Migration Mela**” on 08th & 9th of April, 2017 in “GST Seva Kendra” situated at 2nd Floor, Central Revenue Building, Birchand Patel, Path, Patna from 10:00 AM to 06:00 PM. In the said Mela, the officer of the Department will provide on-spot facility for migration to GST portal to the existing taxpayers. In order to migrate to GST, you are required to bring with you documents evidencing (i) Constitution of Business (ii) Principle place of business (iii) Details of authorized signatory (iv) Details of Bank Accounts (v) Photo and (vi) Any other supporting document as detailed at web-site www.cexpatna.bih.nic.in/ www.gst.gov.in. All Central Excise & Service Tax taxpayers are requested to avail this opportunity. This facility is being provided to all without any charge.
